#### **1. ELIGIBILITY CRITERIA (AS ON 01.07.2018)**

#### **2. TERM OF ENGAGEMENT**

Pharmacists will be engaged on fixed term contract for a period of three years, further extendable in multiples of three years depending upon requirement and individual performance.

#### **3. EDUCATIONAL QUALIFICATIONS:**

- a) Diploma in Pharmacy from an institution recognized by Govt.
- b) Must be registered with the State Pharmacy Council.
