1. ELIGIBILITY CRITERIA (AS ON 01.08.2019)

2. TERM OF ENGAGEMENT

Para Medic will be engaged on fixed term contract for a period of three years, further extendable in multiples of three years depending upon requirement and individual performance.

- (a) Nurse holding Degree/Diploma in Nursing from recognized institute OR
- (b) Pharmacist holding Degree/Diploma in Pharmacy from recognized institute
