Passport accepted as Photo Id. & Address proof (Also if address is current)

International travel or valid Passport declared but not uploaded

Points to be noted:

2. Passport number should be same on both the pages.
3. Passport number should be visible on both the pages.
4. Passport number should match with the number mentioned in your FFP Profile.

1 Passport

*First & Last Two Pages should be Uploaded
*Passport No. should be same on both the pages

Aadhaar card is accepted as Photo ID proof for Resident Indians not holding Passport
Aadhaar Card is also accepted as Address Proof for Resident Indians

(Issues with Aadhaar Card)

IF SAME AADHAAR NUMBER is not REFLECTED on reverse side of the card, THEN:
FULL ALLOTMENT AADHAAR LETTER is required as address proof

Issues with Voter Card as Photo id. & Address Proof (If not holding Passport/Aadhaar card)

Points to be noted:

1. Full Name is mandatory, initials are not accepted.
2. Complete Date of Birth(dd/mm/yyyy) should be displayed.
3. Mentioned Address should match with your profile address.
4. Same Voter ID Number should reflect on both the sides of the card.
